a) all bookings are accepted with reference to The Designer being prepared to accept all the terms and conditions as laid out below.

b) The Management retains the right without incurring any liability to "The Designer ", to change, amend, or decline the booking. The Designer will not be liable to pay for any booking or part thereof which is declined and in the case of Amendments to bookings.

c) No booking shall be transferred or shared with another Designer. All bookings are accepted on the understanding that they will be paid for at the rates in force at the date of this booking, and by the date of each invoice.

d) Once a signed booking form has been received and booking confirmation sent to The Designer. It is The Designer sole responsibility to check the details and ensure that they are correct.

e) The Management may at its sole discretion cancel any booking for which the final balance has not been received by its due date, in which case The Designer will forfeit any payment made or will pay The Management relevant percentage of the booking total. The Management may make any such cancellations as described above without incurring any liability whatsoever to The Management

2. ALLOCATION OF DESIGNER SLOT:

All designer places are decided upon by The Management "PRODUCTION DEPARTMENT" and all Decision by MANAGEMENT are final.

3) CANCELLATIONS:

Once a booking is activated, all fees are non-refundable for whatever reason and the contracts or


